### Juror: Annette Cohen

Dr. Annette Cohen received her BFA from Massachusetts College of Art and Design, an M.Ed. from Antioch New England Graduate School, and her Ph.D. in Leadership and Change from Antioch University. She is an educator by profession and an artist in sensibilities. Her current role as a Professor of Fine Arts and Digital Design includes being a curator for the Gateway Gallery at Great Bay Community College. Her personal work includes drawing, painting, pottery, art history research and digital painting. Her work has been featured in galleries in New England and in Melbourne, Australia. Her passions include visiting galleries and art museums all over the world, and bearing witness to the growth and development of her students.

**Eligibility:** You must be a WCA/NH member, with dues paid for 2017, to enter this exhibition.

**Artwork Specifications:** WCA/NH members may enter two (2) 2D works for consideration. The minimum image size is 22 x 30 inches (about 660 square inches, image only, not to include mat). Work must be wired and ready for hanging. There is no maximum size. Work that differs significantly from the image submitted or that cannot be hung to the juror's satisfaction may be refused.

**Entry fee:** \$20

**Commission:** No commission; the Gallery will pass on Buyers' information to the Artist.

**Insurance:** No insurance provided, but reasonable care will be taken. The Gallery is provided with Security personnel and the School's security system.

**Presentation:** Work must be suitably prepared and ready for presentation. Wall-mounted work must be properly wired for hanging. Work not suitable prepared will not be shown.

**Submission:** electronic, online, in jpeg form. 2D work may include one detail image.

**Artist Statement:** Accepted artists may be asked to submit a short statement of up to 250 words relating to their artwork.
