Eligibility: You must be a current dues paying member of WCA/NH artist to enter this exhibition.

Artwork Specifications: Each artist may submit up to 3 works total, 2-D and/or 3-D. Entry is first come, first serve and a total of 120 works will be accepted. Work must be considered appropriate for all ages.

Entry fee: \$10

Commission: 40/60 with 60% to the artist, 40% to Kimball Jenkins

Presentation: Work must be suitably prepared and ready for presentation. Wall-mounted work must be properly wired for hanging. Work not suitably prepared will not be shown.

Drop off: June 28, 2018, 12pm – 4:30pm, and June 29, 2018, 9am - 12pm, during Kimball Jenkins operating hours. Please arrange to have your pieces dropped off for you if you cannot make these days. All 2-D work must be properly labeled and wired for hanging, **and accompanied by entry sheet**
