

**Prospectus:**  
**WCA New Hampshire 20 Years Celebration: In the Capital**  
**DEADLINE: 11:59 P.M. SEPTEMBER 8, 2015**

*As we continue to celebrate our 20th Anniversary, The Women's Caucus for Art/New Hampshire Chapter will hold three exhibits in Concord during October and November.*

At this time we are taking entries for three venues:

**The Women's Club of Concord, ( October 1–31)**

**The Concord Chamber of Commerce (October 1–31) and**

**The Carolyn Jenkins Gallery at Kimball Jenkins Estate. (October 5–Nov.20)** Think about your work from the last 20 years and choose a favorite or two. If you participated in the Pease Library Show, we do ask that you choose your “other two favorites.”

**Eligibility:** You MUST be an up-to-date dues paying member of WCA/NH to enter this show. You may join or renew your WCA/NH membership via our website, [www.wcanh.org](http://www.wcanh.org) if you wish to participate. This event is NON-JURIED; all entries will be hung as space permits.

**Entry Instructions:** The committee will assign your work to one or more venues and will hang all entries as space permits. You will need to enter here via Entrythingy and have images ready to upload. Your photos do not need to be professional quality since the committee will only use them for assignment to one or more venues. The image must be at least 100K and no larger than 5MB to upload.

**Entry Fee:** \$10.00 for two pieces, payable through Paypal. If you are unable to use paypal, you may use another form of payment by a request to the chairs. See below for contact information.

**Artwork Specifications:** All 2D and 3D original art work is acceptable. Copies of original work will not be shown. All 2D work must be ready to hang with frames and wires. No wet paintings accepted. The committee reserves the right to not exhibit any works that are unsuitably prepared for display or differ significantly from the images submitted. The only venue that can handle 3D work is the Women's Club of Concord (see further descriptions of each venue, below). SIZE RESTRICTIONS for all venues are 40 inches framed width, but the committee reserves the right to place any submitted work in any of the venues. If you participated in the Pease Library Show in Plymouth last spring, please choose your “other favorite” pieces for this show.

**Venues:** *The Women's Club of Concord at 44 Pleasant Street, Concord* will host an exhibit of **Portraits and Figures of Women** in the parlor of their charming Victorian-era house. Space is limited, with some 2D works hanging on the walls and others on easels on the mantel and tables. Small 3D work is also acceptable and will be placed on the mantel and tables as well. Work placed at the Women's Club will remain up from October 1–31

*The Concord Chamber of Commerce at 49 South Main Street, Concord* exhibit requires that you are a member of both WCA/NH and the New Hampshire Art Association, since this is a joint exhibit. NHAA is celebrating their 75th anniversary this year, as we celebrate our 20th. This venue is small, with 17 running feet of display area. Work placed at the Concord Chamber of Commerce will remain up from October 1–31.

*The Carol Jenkins Gallery at Kimball Jenkins Estate at 226 North Main Street*, is a large airy space that can accommodate large and small 2D work but cannot take 3D pieces because the space is rented for other events. Any work that the committee cannot place at the venues above because of space, imagery, or affiliation will be placed here. This show will remain up longer as well, running from October 5 to November 20.

**Sales:** All work will be subject to a 40% commission on sales. NFS is accepted. Please indicate if your work is Not for Sale on the entry form under price.

**Insurance:** Women's Club and the Chamber of Commerce do not carry insurance for art work during this exhibit. Although open to the public, the Chamber of Commerce is staffed at all times. The Women's Club is only open to members and guests at specified times. Kimball Jenkins insures artwork on the premises up to \$40,000.

**Artist's Receptions:** The Women's Club of Concord will hold its Artist Reception on October 2 from 5:30 to 7:30 pm. The Chamber of Commerce will hold an Artists Reception on October 10 during the day (details to follow). Kimball Jenkins will hold their reception October 15 from 5 to 7 pm with the Merrimack River Painters, who will be having a show simultaneously in the Mansion at Kimball Jenkins.

**Artist Statement:** We will not be displaying artists' statements; your work will speak for itself.

#### **DROP AND PICK UP INFORMATION:**

Work assigned to the **Women's Club of Concord or the Chamber of Commerce**, will be dropped off and picked up at the Women's Club (44 Pleasant Street, Concord). **Drop Off: September 26 and 27, noon to 3 pm. Pick up: October 31, noon to 3 pm. We will transfer your work to and from the Chamber of Commerce, which is around the corner at 49 S. Main St.**

Work to be shown at the **Carolyn Jenkins Gallery (the carriage house,) at Kimball Jenkins Estate**, 266 N Main St, Concord, NH 03301 **Drop Off:** October 2, 1-4 pm and October 3, 9 -11 am **Pick Up:** November 21 and November 28, 11 am–2 pm.

If your work is selected to be in two separate venues, the committee will help with arrangements so that you can make just one trip to Concord. Work cannot be kept at any of these venues after the pick-up dates. Please plan accordingly or inquire of the committee chairs: Kate Higley or Paulette Brace.
