How do you see your own relationship with nature and the forest? What aspects of forests or their natural ingredients inspire you? What do you focus on when you experience and respond to groupings of trees?

Bring back your work from the original "Breath of the Forest" for 2020 or create something new - all are welcome for "Breath of the Forest" (Take 2)!

Exhibition Dates: June 1 through June 30, 2021.

Opening Reception: Friday, June 4th, 1-4 p.m.

Entry fee: \$15.00; first come, first served opportunity.

Entry Deadline: May 16 or until we receive 40 works.

Drop off: May 24, 26, 27 between 11:00 a.m. and 2:00 p.m. at
Rochester Museum of Fine Art, Rochester Community Center, Rochester NH.

Pick up: June 30 during take down at RMFA or July 1-2 at RMFA between 11 a.m. and 2:00 p.m.

Eligibility: You must be a 2021 member to enter WCA/NH to enter.

Artwork specifications:

NOTE: IF YOUR WORK WAS ACCEPTED INTO THE PREVIOUS SHOW, IT IS ACCEPTED INTO THIS SHOW, REGARDLESS OF SIZE.

IF YOUR FEE WAS RETURNED TO YOU, YOU WILL, however, NEED TO PAY THE FEE FOR BREATH OF THE FOREST (TAKE 2).

1 piece per artist.

Size limitation for any works: 2D artwork no larger than 36"x36" (unframed). THIS IS A RECENT CHANGE due to many questions. We hope this helps, but please note that it may change the total number of works accepted into the show due to space limitations.

3D artwork no larger than 18"x18"x18". Displayed on tables and front counter space.

Sale of Artwork: Contact artist for private sale.

Commission: No commission charged; donations to Rochester Museum of Fine Art accepted.

Presentation: Artwork must be ready to hang, wired. Artwork must be labeled on the back with: Artist Name, Title, Medium and Price.

Label Information: Sue Pretty and the Rochester MFA will provide labels.

Insurance: Rochester Museum of Fine Art is an insured venue but it is best practice to carry insurance on your persona artwork.

Artist's Statement: is required. A one to two paragraph description of your artwork with the title, medium, size and how your work fits the theme. Include your name and contact information. Email this along with . . .
