



## WCA/NH MEMBERS' JURIED EXHIBITION: Call for Entries

**SUBMISSION DEADLINE: Monday, June 8, 2020**

### EXHIBITION/Theme: *“Narratives: A Woman’s Point of View”*

Every picture tells a story and every point of view has a particular attitude or way of considering a matter. *“Narratives: A Woman’s Point of View”* is a juried exhibition to be held August 1 through August 29 at VynnArt Gallery in Meredith, NH. A narrative is the choice of how to tell a story, what details to share and in what order to relate them. It is a representation or specific manifestation of the story, rather than the story itself. A narrative turns stories into information and knowledge for the recipient. In this show, we will highlight “Narratives” from a woman’s point of view through art. Awards will be presented for 1st Place, 2nd Place and 3rd Place.

**Juror:** Cynthia Cutting, Director, Museum of the White Mountains

**Theme:** *“Narratives: A Woman’s Point of View”*

**Artwork Specifications:** Submissions of 2D and 3D works in all mediums accepted. 1-2 works per artist.

**Awards:** 1st Place, 2nd Place and 3rd Place.

**Entry fee:** \$20 for up to two entries per artist. Non-refundable payment due at time of submission.

**Sales/Commission:** All work must be for sale. VynnArt Gallery will retain a 30% commission on work sold. Payment will be available for pick-up on August 29<sup>th</sup> at the Gallery.

**Liability:** WCA/NH and VynnArt Gallery are not be responsible for any loss or damages to work.

**Presentation:** Work must be suitably prepared and ready for presentation. All wall-mounted work must be properly framed and wired for hanging. Saw tooth hangers, pop-in frames, or standing frames are not allowed. Frames and mats must be clean and in good condition. Works on canvas must be framed unless its “gallery wrapped”, with sides finished, painted, or clean. (no visible staples). Work not suitably prepared will not be shown. Please note that VynnArt shows works from many NH artists. Within the greater gallery, “Narratives: A Woman’s Point of View” will be shown on its own display racks.

**Drop off of Accepted Submissions:** Wednesday, July 29<sup>th</sup>, noon to 5:00 p.m. at VynnArt Gallery in Meredith, NH.

**Pick up:** Sunday, August 30<sup>th</sup>, noon to 5:00 p.m. at VynnArt Gallery in Meredith, NH.
