*Entry fee* is \$10.00.

***Deadline to enter is January 20, 2020, or when we receive 15 works.***

*Commission:* None. *Insurance:* Red River does not carry insurance for artwork.

*Presentation:* Artwork must be properly wired for hanging to be accepted.
